MOAA Council & Chapter Affairs (under Erin Stone, Capt, USN (Ret) and Frank “Tank” Michael, Capt, USN (Ret)) sent out the email blast on 19 Jan 2022. Thursday (14 April 2022) MOAA (Alan English, Vice President, Communications and Marvin Heinze, Capt, USN (Ret)) released CALMOAA Press release via their resources (see attached). I appreciate everything that they have done in support of our effort. In addition to what MOAA has done in support of our efforts. California State Commanders Veterans Council (CSCVC), Ms. Summer Bales, Policy Coordinator, San Diego Regional Chamber of Commerce, Mark Balmert, Rear Adm, USN (ret), President and CEO of San Diego Military Advisory Council and Reeb Government Relations, LLC have all helped us to get where we are today.

On 29 October 2021 I attended the California State Commanders Veterans Council (CSCVC) meeting and I asked them for their support and commitment to support our bill. The CSCVC is supporting our effort with all of their heart. They have sent out a few Voters Voice emails in support of AB 1623 along with a couple of other legislation that affects all of us in the state of California.

In turn every lesson learned we share with MOAA and other states who are also working on legislation who are actively working with their respective state legislators to seek relief from retire military pay – principally, Maryland, North Carolina and Virginia. This can serve as a template as they build their own advocacy support.

Would also like to thank the support that we have received from Ms. Summer Bales, Policy Coordinator, San Diego Regional Chamber of Commerce and Mark Balmert, Rear Adm, USN (ret), President and CEO of San Diego Military Advisory Council.

We started this effort shortly after I became CALMOAA. The first thing Jeff and I did was we started reaching out to our elected officials. We provided PowerPoint Presentations, fact sheets, and we leveraged off SB-007 that California Senator Ben Hueso, 40th District to see if he would resubmit his bill by talking to his office. I had the pleasure of talking to Ms. Ariel Gibbs and later I talked to Jessica Hayes (both ladies are on his staff) and both of them provided some pointers within the realm of their positions. Jeff approached Assemblymember about the ideal and low and behold we have SB 1623 which includes SBP. When you look at your Identification card it says Uniform Services it does not say Military or Armed Services. Yes, on the front of your ID card you will see your service annotated on it. But in the end, it says Uniformed Services which is why our bill is for Uniformed Services increases the scope of voters in California who are affected by this bill. Reeb Government Relations, LLC (Seth Reeb (an Army Veteran), Dana Nichol, and Pete Conaty (consultant to CSCVC) have been instrumental in assisting Jeff and I on this crusade. We have had a bunch of organizations in support of us. Including a letter from Stanley Zezotarski, Col (Retired) USAR member and former President of The National Guard Association of California. [Coast Guard Adm. Linda L. Fagan Nominated to be First Woman to Serve as Commandant](#)

President Joe Biden nominated Adm. Linda L. Fagan to serve as the 27th Commandant of the U.S. Coast Guard. Upon confirmation, Fagan will be the first woman to serve as commandant of the Coast Guard.

CALMOAA is here to help to the best of its ability. Please reach out whenever. Please visit CALMOAA website www.Californiamoaa.com it has a wealth of info about VA and TRICARE benefits, job opportunities and much more.

MOAA Advocacy in Action this year is:

- **The Major Richard Star Act (concurrent receipt for combat-injured servicemembers).** Target legislation is [H.R. 1282](#) with 186 co-sponsors as of Feb. 14 – picking up 35 new co-sponsors this session. The Senate’s bill, [S. 344](#), has 55 co-sponsors as of Feb. 14. We will build on this momentum from last year to get these bills to a floor vote, or have the bill’s language made part of the FY 2023 NDAA with support from House and Senate leaders. This legislation impacts over 50,000 combat-injured service members who were not able to serve their full 20 years due to those injuries. Passage of this bill will also impact current and future members who may face the same fate of early retirements due to combat injuries.
- **TRICARE Mental Health Copayments.** MOAA supports the Stop Copay Overpay Act ([H.R. 4824](#)) – mental health is increasingly important, and the issue is getting attention on the Hill due to pandemic impacts and the effects of social media on children’s well-being. This topic acknowledges the national shortfall of access to quality mental health care and addresses TRICARE’s financial barrier to care when it is available – a problem MOAA can help fix. This legislation will benefit our currently serving families on TRICARE Select and our working-age retirees and their families.
- **Military Pay Raise at 4.6%.** This will be worked in the FY 2023 NDAA with insights in the president’s budget and input from the Armed Services Committees in both chambers. Some legislators are interested in [adjusting pay tables for the junior enlisted](#). We have yet to see details of any such plans, but in the meantime, we remain focused on the 4.6% raise for all ranks. This topic addresses the currently serving and their families (pay and benefits) and is significantly important to those who are about to retire.
- The MOAA AIA website will be live in mid-March for those who want to get a head start on lobbying for these three important topics. Watch for updates at MOAA.org/AiA.



MOAA-Backed Bill Improving SGLI, VGLI Passes Senate

A MOAA-supported bill increasing the amount of life insurance available to servicemembers and veterans via two popular VA plans took a major step forward last week, passing the Senate via a voice vote.

The Supporting Families of the Fallen Act (S. 2794) would increase the automatic maximum coverage under both the Servicemembers' Group Life Insurance (SGLI) and Veterans' Group Life Insurance (VGLI) plans from \$400,000 to \$500,000. It would be the first coverage-cap increase for either plan since 2005.

"This legislation is ultimately about supporting the families of servicemembers," said MOAA President and CEO Lt. Gen. Dana T. Atkins, USAF (Ret). "MOAA looks forward to growing bipartisan support for this important modernization of life insurance."

The bipartisan bill heads to the House for consideration. The House version of the bill (H.R. 3793), introduced in June 2021 by Reps. Chip Roy (R-Texas) and Mike Levin (D-Calif.), has 13 co-sponsors. Sen. Tommy Tuberville (R-Ala.), who introduced the Senate version, told Military.com the bill "has good support" in the House. The bill marks a major step toward adjusting SGLI and VGLI coverage for inflation. According to the Bureau of Labor Statistics inflation calculator, \$400,000 coverage in January 2005 would represent more than \$595,000 in purchasing power in February 2022.

While the \$100,000 increase doesn't cover the entire amount, the legislation could set the stage for Congress to make further adjustments – moves necessary to protect the benefit of these insurance programs and preserve the financial security of military families.

Senate Bill Moves the Needle on Addressing Military Spouse Unemployment

A bill designed to reduce the staggering unemployment rate among military spouses took a major step forward this week with its introduction in the Senate by Sen. Tim Kaine (D-Va.) alongside Sens. John Boozman (R-Ark.), Maggie Hassan (D-N.H.), and Mike Rounds (R-S.D.).

The Military Spouse Hiring Act (S. 3909), the Senate companion to H.R. 2974, would expand the Work Opportunity Tax Credit (WOTC) to create a new target group for military spouses, whose jobless rate has remained between 22% and 24% for over a decade.

Congress established the WOTC in 1996 to incentivize businesses to hire members of select target groups who face significant barriers to employment. There are currently 10 target groups, including qualified veterans, ex-felons, and Supplemental Nutrition Assistance Program (SNAP) recipients.

Employers who take advantage of WOTC receive a tax credit equal to 40% of up to \$6,000 of wages paid to, or incurred on behalf of, an individual from one of the target groups in their first year of employment who performs at least 400 hours of work for that employer.

Military-mandated moves every two or three years have a significant impact on a spouse's ability to find and maintain employment. Additionally, employed spouses often see their résumés discarded by future hiring managers due to the sporadic nature of work experience (different locations and jobs) and gaps in employment history resulting from short assignments (a school, for example).

Reducing the high unemployment and underemployment rates among military spouses will take a multipronged approach:

- **Programs and Resources:** DoD must maintain and expand programs and resources focused on enhancing professional development, upskilling, and education.
- **Licensure Portability:** The Defense-State Liaison Office must continue to develop interstate compacts for the multiple professions requiring licenses or certifications. The licensure/certification fee reimbursement program is a positive step toward addressing fees associated with PCS moves.
- **Incentivized Hiring:** Businesses are reluctant to hire military spouses due to the short time they typically reside in one location. Including military spouses as a target group under WOTC is an important policy lever to address this reluctance.

MOAA continues to work closely with colleagues at the National Military Family Association and Hiring Our Heroes to increase awareness of this important legislation – one more tool to address the military spouse unemployment rate. With

nearly a third of servicemembers considering leaving the service because of concerns with spouse employment, this is not just an issue of family financial well-being — it’s a recruitment and retention issue.

Military Treatment Facilities Adding QR Codes to Prescription Packaging

Throughout 2022, military treatment facility (MTF) pharmacies will be replacing printed monographs or MedGuides (the paper medication guides that come with many prescription drugs) with QR codes on prescription packaging. Patients can request a paper copy if they prefer the printed version.

Benefits of switching to QR codes for drug monographs include reduced use of paper, increased privacy of patient information, and the ability to share more robust information in a variety of formats to best meet patient needs. Scanning the QR code will open a web link allowing patients to access prescription information sheets, brief informational videos, tools to help remind you to take your medication, and the ability to share information about your medication with family members, caregivers, or health care professionals.

qr-code-legislative-action-center.png The use of QR codes has exploded during the pandemic as establishments switched to digital options for everything from restaurant menus to real estate listings to MOAA’s Legislative Action Center (code pictured). Most mobile phones have a QR code reader integrated into the camera. To access drug information, open your phone’s camera and point it at the QR code on your prescription vial from about 6 inches away. It will scan automatically and provide a link to additional information.

MOAA supports efforts to modernize MTF pharmacy services, and we appreciate the Defense Health Agency has maintained the option of printed prescription drug information for those who prefer to receive a printed copy. Air Force pharmacies began implementing QR code technology in 2019, so some MOAA members already may have encountered QR codes on their prescription vials.

Your MTF pharmacist is also a resource for information about your prescriptions. Patients are still encouraged to ask their pharmacist any questions they may have about their medications.
